Eligibility Requirements:

1. A student in a senior secondary school may apply for this scholarship. Preference is given to a School District #63 student who is related to a member of CUPE Local 441 under one of the following conditions:
 - a. a son or daughter
 - b. in a blended family situation, the spouse's son or daughter
 - c. a child for whom the member is the legal guardian
 - d. a foster son or daughter for whom the member is still responsible.
2. Consideration is given to a son or daughter of a CUPE Local 441 member who is attending secondary school in another school district
3. In the event that no descendent of a CUPE Local 441 member applies, consideration is given to other applicants.
4. The student should be graduating and continuing within the same year to a recognized post secondary educational institute. Priority will be given to candidates who have met the entry requirements for their desired program and in their graduating year provide proof of registration. A school counsellor must sign the student's application. First choice is always given to a candidate who has met the entry requirements for courses such as Trades Apprenticeship, LPN, Cooks Training, Cosmetology, Resident Care Aide, Criminal Justice, Lab Assistant, etc. The following candidates will also be considered:
 - a. Candidates who submit proof of being placed on a waiting list for their program. If awarded the scholarship, they will have up to two full years to submit proof of acceptance by providing copies of receipts of registration.
 - b. Children of CUPE members who have not applied for this scholarship in the past may do so providing the child is already attending a recognized post secondary educational program. The student must not be beyond his/her second year of the program, and must provide proof of registration for courses in the upcoming third year. If the candidate is awarded the scholarship he/she will have until December 31st of the award year to submit copies of receipts.
5. For a senior secondary student, a transcript of marks from Grade 11 and 12 (interim 2nd semester marks) and a resume indicating past accomplishments and outlining future plans must be submitted along with this application before June 15th.
6. Students currently attending a recognized post secondary educational institute must submit a transcript of their last semester marks. They must also include a resume indicating past accomplishments and outlining future plans, which must be submitted along with this application by September 15th.
7. All things being equal, need will determine awarding of funds.

Please Note:

- **This scholarship is NOT applicable to students taking University transfer courses or attending University.**
