









Stats Summer 2024 – Total Incidents

2024/06/30 - 2024/09/03






Stats Sept-Oct – Total Incidents






Public School District remains its own rate group. The industry saw a consistent increase in cost rate until 2022 when the cost rate decreased. However, the cost rate has increased again since 2023, and the base rate exceeds the cost rate for the fourth year in a row due to rate group deficit.



Time-loss claim injury rate








Time-loss claim costs

Top 5 accident types, 2019-2023










Time-loss claim counts

Experience rating: It's all about balance

- Firms whose claims costs are the same
 as those of other similar-sized firms in
 their industry are considered "average"
 and pay the industry's base premium
 rate.
- Best-performing firms can qualify for up to a 50% discount on their premium rates while worst-performing firms may pay a surcharge of up to 100%.




